

Notice of Petition to Amend Charter: New Location – **WMST PCHS Inc.** ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: March 19, 2018

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request submitted by Washington Mathematics Science and Technology Public Charter High School, Inc. (WMST PCHS Inc.) on February 2, 2018 to relocate to a new facility.

WMST PCHS Inc. is currently in its nineteenth year of operation serving students in grades 9-12 at a single campus located in Ward 5. Effective for school year 2018-2019, WMST PCHS Inc. requests to relocate from 1920 Bladensburg Road, NE to 711 Edgewood Place, NE, which is also located in Ward 5. The school reports this relocation will allow WMST PCHS Inc. to operate in a facility with state-of-the art science laboratories for each science classroom, additional computer workrooms and a larger media center. Additionally, the school anticipates new opportunities for recruitment and increased student enrollment due to the prime location of its proposed facility near other middle schools and a large apartment development.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its campus locations.
