

Notice of Petition to Amend Charter: ECI and New Facility – **Community College Prep PCS**

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: April 23, 2018

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request submitted by Community College Prep Public Charter School (CC Prep PCS) on March 7, 2018 to increase its existing enrollment ceiling and add a third facility effective for SY 2018-2019.

CC Prep PCS is currently in its fifth year of operation serving adult students at a single campus with two separate facilities. The school is requesting an enrollment ceiling increase of 625 students, from its existing maximum enrollment of 600 students, to a new maximum enrollment of 1,225 students by SY 2022-2023. Additionally, effective for SY 2018-2019 and beyond, the school plans to operate at a third facility located at Hope Village, a halfway house for DC residents that transition back into society after incarceration. If approved, these amendments will allow the school to pursue additional community partnerships and serve more adult students in the District.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its enrollment ceiling and campus locations.
