Goals and Academic Achievement Expectations – **E.L. Haynes PCS**

**SUMMARY:** The District of Columbia Public Charter School Board (“DC PCSB”) announces an opportunity for the public to submit comment on a request submitted by E.L. Haynes Public Charter School (E.L. Haynes PCS) on January 12, 2018 to amend its goals and academic achievement expectations.

E.L. Haynes PCS is currently in its fourteenth year of operation serving students in grades prekindergarten-3 through twelfth at three campuses in Ward 4. In preparation for its upcoming 15-Year Charter Renewal in school year 2018-2019, the school requests to adopt the Performance Management Framework as its measure for goals and academic achievement expectations.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its goals and academic achievement expectations.
