

Notice of Petition to Amend Charter: Competency-Based Program – Friendship PCS

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: October 23, 2017

SUMMARY: The District of Columbia Public Charter School Board ("DC PCSB") announces an opportunity for the public to submit comment on a request submitted by Friendship Public Charter School ("Friendship PCS") on September 15, 2017 to make several changes to its charter agreement, including a campus name change and updated addresses for two of its campuses and its community office. The school also seeks a waiver to offer competency-based credits in its high school programs effective for SY 2017-2018 and beyond.

Friendship PCS is currently in its nineteenth year of operation serving students in grades PK3-12 at twelve campuses across the District. Specifically, the school requests the following amendments:

Updated Campus/Office Addresses

Friendship PCS Armstrong: New address at 111 O Street, NW

Friendship PCS Online Academy: New address at 1351 Nicholson Street, NW Friendship PCS Community Office: New address at 1400 First Street, NW, 3rd Floor

Campus Name Change

Effective immediately, Friendship PCS Woodridge Elementary and Middle Campuses will be called:

- 1. Friendship PCS Woodridge International Elementary
- 2. Friendship PCS Woodridge International Middle

Competency-Based Credits

Effective for SY 2017-2018, Friendship PCS seeks a waiver to offer competency-based credits in its high school programs to enhance students' individualized learning pathways and provide additional options for credit recovery.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its campus names, addresses and credit offerings.
