

## Notice of Petition to Amend Charter:

## Goals and Academic Achievement Expectations - Goodwill Excel PCS

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: September 18, 2017

**SUMMARY**: The District of Columbia Public Charter School Board ("DC PCSB") announces an opportunity for the public to submit comment on a request submitted by Goodwill Excel Center Public Charter School ("Goodwill Excel PCS") on March 28, 2017 to amend its goals and academic achievement expectations.

Currently in its first year of operation, Goodwill Excel PCS is an adult high school that serves grades 9-12. The school proposes to amend some of its existing goals so school staff will have a clear, measurable way to evaluate and demonstrate the school's impact on academic achievement, Goodwill Excel PCS's success in carrying out its mission. The school will be up for charter renewal in 2031.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its goals and academic achievement expectations.
