**SUMMARY:** The District of Columbia Public Charter School Board ("DC PCSB") announces an opportunity for the public to submit comment on a request submitted by Latin American Montessori Bilingual Public Charter School (LAMB PCS) on November 27, 2017 to amend its goals and academic achievement expectations.

LAMB PCS is currently in its fifteenth year of operation serving students in grades prekindergarten-3 through fifth at a single campus with multiple facilities in Wards 4 and 5. In preparation for its 15-Year Charter Renewal, the school requests to adopt the Performance Management Framework as its measure for goals and academic achievement.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its goals and academic achievement.
