

## Notice of Petition to Amend Charter –Additional Facility Mary McLeod Bethune Day Academy Public Charter School

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: July 20, 2015

**SUMMARY**: The District of Columbia Public Charter School Board ("PCSB") announces an opportunity for the public to submit comment on a request submitted by Mary McLeod Bethune Day Academy Public Charter School ("MM Bethune PCS") on May 28, 2015 to amend its charter by adding a new facility in School Year ("SY") 2015-2016.

MM Bethune PCS is currently in its 11<sup>th</sup> year of operation serving students in grades prekindergarten-3 through eighth at a single campus located in Ward 5. Beginning in SY 2015-2016, MM Bethune PCS would also like to add a new facility location at the 6<sup>th</sup> Presbyterian Church Education building, located at 5413 16<sup>th</sup> Street, NW, in Ward 4. This facility happens to be the school's original facility at the inception of MM Bethune PCS in 2004. The proposed new building is currently being occupied by a licensed private preschool program.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its facility locations.
