



Notice of Petition to Amend Charter:
Campuses and Facilities – **Eagle Academy PCS**

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: **January 27, 2020**

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a written request submitted by Eagle Academy Public Charter School (Eagle Academy PCS) on December 9, 2019 to relocate and rename its campus in Ward 6 beginning in school year (SY) 2020-21.

Eagle Academy PCS is currently in its seventeenth year of operation educating students in grades prekindergarten-3 through third at two campuses located in Wards 6 and 8. The school's Ward 6 campus is presently on New Jersey Avenue SE, and its Ward 8 campus is on Wheeler Road SE. The school also owns a property located at 2345 R Street SE in Ward 8, which Eagle Academy PCS plans to sell to another charter school in the coming months. Per the school's amendment application, effective for SY 2020-21, Eagle Academy PCS will relocate its Ward 6 campus to a new location in the same ward, at 1900 Half Street SW. The school will also continue to operate its existing campus on Wheeler Road in Ward 8.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its campus/facility locations.
