DATE: October 19, 2020

#### <u>Proposal</u>

The DC Public Charter School Board (DC PCSB) staff recommends its Board open for public comment updates to the COVID-19 Impact Policy, which clarifies how DC PCSB staff will implement key policies and practices impacted by the COVID-19 pandemic for school year (SY) 2020-21. Public comment will remain open until November 19, 2020, with a public hearing on November 16, 2020. This policy will be voted on at DC PCSB's December 2020 board meeting.

# **Policy and Guidance Summary**

In May 2020, DC PCSB adopted the <u>COVID-19 Impact Policy</u><sup>1</sup> in response to the COVID-19 public health emergency that resulted in all DC public charter schools physically closing in March 2020 and implementing distance learning programs for the remainder of SY 2019-20. Given the ongoing pandemic and continued use of distance learning, staff is recommending additional adjustments to our policies and practices for SY 2020-21. Below is a summary of the most significant of these adjustments, followed later in this document by a comprehensive

overview of all proposed changes. A redlined version of the policy may be found at Attachment A.

- DC PCSB will not score or tier the 2020-21 Performance Management Framework (PMF).
  - DC PCSB will publish a School Quality Report that displays measures based on available data (e.g., PARCC, attendance, etc.).
  - Measures will include sector-level comparisons where available; floors and targets will not be included on the report.
  - Data points that have historically been display only on the PMF (e.g., PK and K-2 literacy and math measures, mission specific measures) will be optional for schools to both submit and display on the scorecards.
  - On the scorecard, there will be an opportunity for each local education agency to provide additional narrative about the school year.
- DC PCSB will collect data for goals and academic achievement expectations but will not use the data to evaluate goal attainment for the purposes of charter reviews and renewals for SY 2020-21.
  - In all charter review and renewal reports, goal outcomes will be displayed, but will indicate that goal attainment cannot be determined for this year due to disruptions caused by COVID-19.
  - Schools will not be penalized for failure to report on goals data that is unavailable or impractical due to public health conditions.

# <u>Background</u>

In response to the COVID-19 public health emergency, District of Columbia Public Schools and public charter schools physically closed on or before March 16, 2020 in accordance with a directive from the Mayor, and remained in virtual status through the remainder of SY 2019-20. In coordination with public health officials and the Deputy Mayor of Education, all public charter schools started SY 2020-21 either 100% virtual or in a hybrid mode of instruction.

While all public charter schools developed and implemented distance learning plans for their students, student access to the material may not be equitable due to varying internet access, living situations, or other factors. Given these factors, DC PCSB staff concluded it would be inappropriate to score and tier the 2020-21 PMF.

# Proposed Changes to DC PCSB Policies and Oversight

Note: The guidance in this document supersedes any conflicting guidance, contained in DC PCSB's existing policies or elsewhere, but only for the period of time indicated.

# 2020-21 PMF Policy & Technical Guide and School Quality Report

As noted above, DC PCSB will publish a School Quality Report scorecard with available display data (e.g., student achievement, attendance, etc.) and include sector-level comparisons when possible. In the spring of 2021, DC PCSB will engage schools and other stakeholders to determine which data will be used and how it will be displayed to finalize the SY 2020-21 PMF Policy and Technical Guide. The PMF will not display floor and target ranges for any measure.

Data points that have historically been display only on the PMF (e.g., PK and K-2 literacy and math measures, mission specific measures) will be optional for schools to both submit and display on the scorecards.

# 2020-21 Charter Goals

DC PCSB will collect data for a school's SY 2020-21 charter goals and academic achievement expectations but will not use the data to evaluate goal attainment (e.g. met/not met). DC PCSB will display the data for school's goals in the review and renewal reports for SY 2020-21 and the data may be used by the Board as discretionary evidence, but only if it helps the school.

### **Other Policies and Practices**

The revisions to the COVID-19 Impact Policy – SY 2020-21 detail all adjustments to DC PCSB's policies and practices. Many of these oversight and monitoring tasks are returning to normal implementation.
