

Notice of Request to Amend Charter: Enrollment Schedule, Goals – **Paul PCS** Open for Public Comment

Public Comment Accepted Until July 18, 2022

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to comment on a request from Paul Public Charter School (PCS) to amend its charter agreement. The school seeks to modify its enrollment schedule and goals and academic achievement expectations (goals) ahead of school year (SY) 2023 – 24. The school submitted its request on June 21, 2022.¹

The local education agency (LEA) is already authorized to enroll students in grades 5 through 12; however, it only enrolls students in grades 6 through 12. The Paul PCS board of trustees voted to begin enrolling fifth graders in SY 2023 – 24. Consequently, the school proposes amending the enrollment schedule in its charter agreement, which only includes grades 6 through 12. Below, see the proposed enrollment schedule, which aligns with the school's 875-student enrollment ceiling.

The school also proposes amending is goals. The school adopted the Performance Management Framework (PMF) as its goals for grades 6 through 12. Beginning in SY 2023 – 24, Paul PCS proposes adopting the PMF as its goals for grades 5 through 12.

Paul PCS opened in 2000 under authorization from DC PCSB. The LEA serves 743 students across two campuses in Ward 4. The school's mission is to "educate our

students and develop in them the capacity to be responsible citizens, independent thinkers and leaders."
