

Notice of Charter Reviews and Renewals – **Multiple Schools**: Achievement Prep PCS Center City PCS Sela PCS Yu Ying PCS Open for Public Comment

Public Comment Accepted Until December 19, 2022

**SUMMARY**: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comments on the DC public charter schools listed below, which are up for a charter review or renewal on December 19, 2022. Pending DC PCSB staff's analysis, the Board may elect to do one of the following for schools up for review: 1) continue the school's charter without conditions, 2) conditionally continue the school's charter by imposing annual or interim targets or requirements it must meet, or 3) commence charter revocation proceedings. For schools up for renewal, the Board may elect to do one of the following for each school: 1) renew the school's charter **or** 2) commence charter revocation proceedings.

1. <u>Achievement Preparatory Academy Public Charter School (Achievement Prep PCS):</u>

Achievement Prep PCS is up for its 15-year charter renewal. The school operates a single campus in Ward 8 where it serves students in grades pre-kindergarten 3 (PK3) – 4. Its mission is to "prepare students in grades four through eight to excel as high-achieving scholars and leaders in high school, college and beyond."<sup>1</sup>

2. <u>Center City Public Charter School (Center City PCS)</u>:

Center City PCS is up for its 15-year charter renewal. The school operates six campuses in Wards 4, 5, 6, and 8, where it serves students in grades PK3 – 8. Its mission is to "empower students for lifelong success by building strong character, promoting academic excellence, and generating public service throughout Washington, DC."

3. <u>Sela Public Charter School (Sela PCS)</u>:

Sela PCS is up for its 10-year charter review. The school operates a single campus in Ward 4 where it serves students in grades PK3 – 5. Its mission is to "offer children of all ethnic and socioeconomic backgrounds in the District of Columbia, from pre-kindergarten to 5<sup>th</sup> grade, the opportunity to achieve academic

excellence in a safe, nurturing environment that focuses on Hebrew language immersion, promotes the value of diversity and provides the skills for taking action in the world."

4. Washington Yu Ying Public Charter School (Yu Ying PCS)

Yu Ying PCS is up for its 15-year charter review. The school operates a single campus in Ward 5 where it serves students in grades PK3 – 5. Its mission is to "inspire and prepare young people to create a better world by challenging them to reach their full potential in a nurturing Chinese/English educational environment."

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., DC PCSB is required to review each DC public charter school's performance at least once every five years.

**PUBLIC MEETING**: DC PCSB will discuss and vote on Achievement Prep PCS, Center City PCS, Sela PCS, and Yu Ying PCS's charter review or renewal on December 19, 2022 at 6:00 pm. Please check <u>www.dcpcsb.org</u> to register to attend the meeting.
