

Notice of Petition to Amend Charter:
Program Replication – **AppleTree PCS**Open for Public Comment
Public Comment Accepted Until July 17, 2023

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from AppleTree Early Learning Public Charter School (AppleTreePCS) to amend its charter agreement by replicating its program beginning in school year (SY) 2024 – 25. The school submitted its request on June 1, 2023.¹

Founded in SY 2003 – 24, AppleTree PCS educates 491 students in grades pre-kindergarten-3 (PK3) and pre-kindergarten-4 (PK4) across six campuses in seven facilities across Wards 1, 3, 6, 7, and 8. The school's mission is "to provide young children with the social, emotional and cognitive foundations that will enable them to succeed in school."

The school seeks to convert the facility located at 4900 Massachusetts Avenue NW, which is part of AppleTree PCS – Oklahoma Avenue, into a stand-alone campus. The proposed AppleTree PCS – Spring Valley will replicate the program at the school's existing six campuses, enrolling 154 PK3 – PK4 students at capacity. In alignment with *DC PCSB's Definition of School, Campus, and Facility Policy*,² the campus will serve a distinct grade span with a dedicated academic leader, have charter goals and academic expectations separate from the other campuses, and receive its own accountability report.
