

Notice of Petition to Amend Charter Goals Policy Open for Public Comment Public Comment Accepted Until April 8, 2024

SUMMARY: The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comments on the Charter Goals Policy. DC PCSB staff seeks revisions to the Charter Goals Policy. The proposed revisions aim to consolidate and expand upon existing DC PCSB charter goals policies and guidelines, creating a single comprehensive policy.¹ Further, the revisions will ¹) align with standards defined in the Annual School Performance Index Report and Evaluation (ASPIRE) Policy & Technical Guide (DC PCSB's revised accountability system), and 2) establish goal attainment pathways for school year (SY) 2024 – 25 through SY 2026 – 27 as DC PCSB begins its implementation of the ASPIRE System. The proposed Charter Goals Policy and the ASPIRE Policy & Technical Guide will serve as complementary components of DC PCSB's accountability system.

The proposed policy is divided into three sections, as follows:

- 1. Adopting and Amending Charter Goals describes the guidelines DC PCSB will use to negotiate and recommend approval for new and amended charter goals. Most notably, it establishes the process by which schools may elect to adopt ASPIRE as charter goals. It also codifies DC PCSB's current and historic practice surrounding both minimum standards for individually negotiated charter goals and expectations for goal targets, assessments, and business rules.² Finally, it captures the process and timeline for charter goal amendment requests, as well as grounds for removing goals or lowering goal targets.
- 2. **Goal Determination in SY 2022 23 Through SY 2026 27** describes how DC PCSB will assess goal attainment in charter reviews and renewals for the listed school years. For goal determination in SY 2022 23 and SY 2023 24, the guidance is largely unchanged from the July 2023 Charter Goals Policy and

includes multiple pathways for goal attainment each year.³ For SY 2024 – 25 and SY 2025 – 26, the policy continues to offer all schools a pathway for goal attainment when demonstrating improvement in outcomes over time, including for schools that elect to adopt ASPIRE as their charter goals.

3. Charter Goals Monitoring and Consequences for Underperformance describes DC PCSB's processes for monitoring schools' progress in meeting charter goals and the possible actions taken when a local education agency (LEA) is not meeting its charter goals. Consequences for underperformance on the ASPIRE System included within the policy are a reiteration of the standards established in the ASPIRE Policy & Technical Guide.

In SY 2024 – 25, DC PCSB will begin implementing the ASPIRE System and move away from the use of transitional goals and other alternative pathways for goal attainment. See the table below for a description of the goal attainment pathways DC PCSB proposes applying to schools with ASPIRE as goals (or current PMF as goals schools pending adoption of ASPIRE or new individually negotiated goals) and schools with individually negotiated goals in SY 2024 – 25 through SY 2026 – 27.
