Asset Acquisition of Eagle Academy PCS,  
Enrollment Ceiling Increase, Facilities, Campuses – **Friendship PCS**  
Open for Public Comment  
**Public Comment Accepted Until August 14, 2024**

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from Friendship (PCS) to amend its charter agreement. The school plans to acquire the assets of Eagle Academy PCS, including its students and campus locations, beginning in school year (SY) 2024 – 25. The school submitted its initial request on July 29, 2024, then an updated application on August 1, 2024.<sup>1</sup>

In its 26<sup>th</sup> year of operation, Friendship PCS educates 4,548 students in grades pre-kindergarten 3 (PK3) through 12 across 15 campuses and 11 facilities. The school has a current enrollment ceiling of 5,115 students.

To accommodate the asset acquisition, Friendship PCS seeks a charter amendment to add two facilities and campuses as well as increase its enrollment ceiling. The school proposes to operate from 3400 Wheeler Road SE (Ward 8) and 1900 Half Street SW (Ward 6). These facilities are the addresses of Eagle Academy PCS – Congress Heights and Capitol Riverfront respectively. Also, the school requests an enrollment ceiling increase of 508 students over five years. Between SY 2026 – 27 and 2030 – 31, the maximum enrollment total would increase from 5,115 to 5,623.
