

## Notice of Petition to Amend Charter: Graduation Requirements – **BASIS DC PCS** Open for Public Comment

## Public Comment Accepted Until May 19, 2025

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from BASIS DC Public Charter School (PCS) to amend its charter agreement by revising its graduation requirements. The school submitted its request on March 28, 2025.<sup>1</sup>

BASIS DC PCS seeks to make the following adjustments beginning in school year (SY) 2025 – 26.

- Students in grade 8 may earn 1.0 Elective credit and 1.0 Foreign Language credit for passing high-school level courses.
- Students must earn 1.0 Advanced Placement (AP) Economics credit, replacing the previous 0.5 Economics credit.
- The graduating classes of 2030 and beyond must earn 26.0 total credits, instead of 25.5. credits.

BASIS DC PCS began operation in SY 2012 – 13 and educates students in grades 5 - 12. The school currently enrolls 692 students at one facility located in Ward 2.
