

## Notice of Petition to Amend Charter: Educational Approach – **Kingsman PCS** Open for Public Comment

## Public Comment Accepted Until September 15, 2025

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request from Kingsman Academy Public Charter School (Kingsman PCS) to amend its charter agreement by adding an element to its educational approach. The school submitted its request on July 28, 2025.

Kingsman PCS seeks to codify its piloted residential program called "Quest." In this program, middle and high school students "earn credits through cultural excursions across the U.S. and around the globe." This amendment will allow the school to receive per-student residential funding beginning in school year (SY) 2026 – 27.

Opening in SY 2015 – 16, Kingsman PCS educates 346 students across grades 6 – 12 at a single facility in Ward 6. Its mission is "to provide an individualized and rigorous education in a supportive environment to prepare scholars for post-secondary success and responsible citizenship."
