 - a. Leadership spent this semester identifying goals and priorities for the remainder of this year and the next two years
 - b. Finances: Good financial standing
 - i. 112 days of cash on hand
 - c. COVID
 - i. No positive cases since October
 - ii. Weekly testing continues (~47% of students)
 - iii. Held vaccine clinic, 1st and 2nd doses; an estimated 50% of eligible students are vaccinated
 - d. Playground
 - i. Broke ground and began construction
 - ii. \$157,000 in funding secured, \$68,000 coming from OSSE
 - iii. Fundraising gap of \$52,000
 - e. Academics
 - i. Progress reports and conferences coming in January
 - ii. Progress reports focus on skills and abilities
