2. ED Update (J. Gomez)

- Staff Celebrations
 - Thanks to Board Members who have contributed to support staff appreciation
 - School is working on monthly celebrations to become a part of the traditions, but also an opportunity to build community get to know each other better
 - Staff celebration week will occur in May (May 1 6)
 - o End of Year celebration in June
- Facilities and St. Elizabeth Project Update--
 - Group has heard heard from the city and the proposal has to be rewritten. They
 lost the city agency commitment they initially had. Having a city agency was a
 requirement, so they will now have to resubmit.
 - o There is a Barry Farm revitalization group as well, and school will speak to them
 - School has visited 2 other locations as well
 - The school desire is to move next summer; enrollment will dictate the need
- Student applications and enrollment update
 - School had 167 applicants before the lottery closed.
 - School will have a waitlist for next school year's admissions
 - o 61 students ranked I Dream in the top 3
 - 51%- from Ward 8
 - 37%- from Ward 7
 - o 58 applications in PreK 3 which is almost triple the number from last year.
- Staff Intent to return--
 - Everyone, except for 2 (who are undecided), plan on return next year



- School is exploring some new positions and the opportunity to repurpose some positions
- Discussion of Student Attendance
 - Working to better position practices and procedures for Coaches at the school
 - There is still some apprehension with some families around COVID positivity rises; school continues to communicate with families and encourage in-person attendance
