- 7. Governance Report David Carl and Sarah Snyder
 - a. David Carl and Sarah Snyder reported on the following topics:
 - i. Sarah Snyder is the new chair of the Governance Committee.
 - ii. The primary business of the committee has been related to the search for new trustees. We are excited to welcome Dahlia to the board.
 - iii. The committee has also discussed how it can support the search for a new Executive Director.
- 8. Athletics Committee Report David Carl, Committee Chair
 - a. David Carl reported on the following topics:
 - i. The Athletics Committee is the newest committee.
 - ii. They have been working with the DCI Athletic Director to create a strategic five year plan. We are one of the largest middle and high schools under one roof, and we are excited to have a strategic plan.
 - iii. Varsity baseball and lacrosse teams will begin this year.

- 9. Education Committee Shalini Shybut and Principal Nace
 - a. Shalini Shybut and Chris Nace presented on the following:
 - i. We are excited to be talking about IB results. This type of education is usually only available to privates, not diverse public schools.
 - ii. The committee discussed how to bolster and support the staff during the pandemic.
 - iii. In February, the committee would like to analyze data to see where resources need to be allocated.
 - iv. Chris Nace presented on our IB and graduation results:
 - 1. Graduation:
 - 9.a.iv.1.1. 96% high school graduation rate
 - 9.a.iv.1.2. 93% college acceptance rate
 - 9.a.iv.1.3. Over \$9 million in scholarships
 - 2. IB Results:
 - 9.a.iv.2.1. DCI out-performed in every single area in comparison to other DC schools.
 - 9.a.iv.2.2. Last year, 52% of students earned their DP, which increased by 20% this year.
 - 9.a.iv.2.3. Two students received their IB Bilingual Diplomas.
 - 9.a.iv.2.4. Fifty-eight percent received their CP.
 - 9.a.iv.2.5. We only had 10 students who were not full IB candidates.
 - 9.a.iv.2.6. Sixty two of our students received a Seal of Biliteracy.
 - 3. What is next:
 - 9.a.iv.3.1. Exams will be held from May 3rd to May 19th.
 - 9.a.iv.3.2. CAS hours were waived by the IB. The District has submitted a waiver to waive the 100 hours of community service needed for the DC high school diploma.
 - 9.a.iv.3.3. Eleventh graders have begun their process for the extended essays.
 - 9.a.iv.3.4. Current 10th graders have chosen their pathways for next year. Just over half have selected the CP. We believe that this is due to the addition of the health sciences track.
 - v. DC is not rating schools at this time due to the lack of PARCC and other testing data. However, they did release some data, where we outperformed the city in every metric.
 - vi. Questions/Comments:
 - Is there a petition to not have the IB test happen this year? That
 has been an ongoing conversation. There is a lot of debate about
 whether these IB exams will take place. The IB has been very firm
 that students must sit for exams.
 - 2. What are you forecasting for this year since students will be sitting for IB exams for the first time? We have the same number of students preparing to sit for the exams as in past years. Oral exams start this Friday for English. We have also been working

- with our seniors because of the stress and rigour of the program, especially since they were virtual for all of last year. I expect the results to show that we have students performing above the 50% mark. I don't expect to see any difference, if not outperforming where their peers have been.
- 3. Do we have more students this year going for the bilingual diploma? We have more students interested in it, but we don't know if they will sit for it. I don't anticipate more students sitting for it due to stress and time management.
- 4. Do you see a trend in who has been successful in the DP? Our students who don't sit for the exams are overwhelmingly English Language Learners and students with disabilities. We have expanded support for those students but I feel that we need more development in that area. Typically those students do not have access to the IB in the city. We do outperform the city but we are not where we need to be. We have created smaller classes and we have also hired new teachers who are qualified IB teachers. Same with the ELL students.

- 6. Students with 504 plans are the highest performing students within the building.
- 10. Finance Committee Leroy Clay
 - a. Leroy Clay presented on the following topics:
 - We have begun looking at the budget for next year and preparing for long term planning.
 - ii. The school continues to perform very well. We are forecasting to outperform the budget in revenue by about \$2M. This is due to the higher per pupil funding provided than what we budgeted for. We do have some savings due to salaries of open or recently filled roles.
 - iii. We will end the year in a very strong position with \$9M of cash on hand.
 - iv. Questions/Comments:
 - 1. How are we able to change the timeline so that we know the per pupil funding before we finalize our budget? Both years that this has happened, the Mayor's budget timeline was pushed back. This year, the Mayor will submit her budget to council in March and we will be able to include that in the budget. It does not harm us. We take a stance to be more conservative in our approach which protects our budget position. Ultimately, we will not know the final budget until Council's decision, which will likely happen after we finalize our budget.
 - 2. It may be challenging to shift the timeline based on decisions that need to be made at the school. We create different scenarios so that we have a plan no matter what happens.

- 3. Our biggest concern this year will be inflation and cost-of-living-adjustment.
- 4. We do have until the end of June, which gives us more time to make decisions.
- 11. Public Affairs Report Deanna Troust
 - a. Deanna Troust reported on the following topics:
 - i. Ongoing impacts of COVID on the school, especially on the communications front.
 - ii. Working to be as transparent as possible regarding COVID cases, exposures, etc., with staff and families.
 - iii. Recruitment into DCI is underway. We currently have 797 applications to DCI across all grades and languages. We also have dates for upcoming buddy days, which may be reverse or virtual.

 - ii. Fundraising: The Voyager Fund has expanded to other things beyond international trips.

3. Accountability is changing significantly at the moment. Many state assessments and other accountability frameworks are on pause.

vi. Engagement and Culture

- 1. Student engagement and culture is shown in re-enrollment. Students want to stay at DCI.
- 2. Re-enrollment is consistent over groups and grade levels.
- 3. Attendance is much higher than the secor average.
- 4. The Kelvin survey, which measures wellness, showed strong data around agency and engagement.
- 5. Area of concern: Students and staff are struggling with resilience. Today's mental health struggles are showing.

vii. Student Achievement

1. Fall 2021 MAP Achievement

- 6.a.vii.1.1. MAP is a norm-based math and reading assessment. The majority of students at DCI are performing above average versus national norms.
- 6.a.vii.1.2. We have not seen the level of learning loss that other schools have seen in the city. We did notice gaps for particular groups of students in subjects like math and for students with disabilities and English language learners.

2. STAMP Scores

- 6.a.vii.2.1. The Spanish STAMP average is very high. There is some difficulty in supporting advancement in Chinese, especially when students do not have a background in Chinese.
 - 3. IB Participation and Performance
- 6.a.vii.3.1. DCI greatly outperforms the city in terms of participation and performance, but there are some gaps in participation for students with disabilities, English learners, and students designated at-risk.
- 6.a.vii.3.2. Nationally, less than 1% of students participate in IB programs.
- 6.a.vii.3.3. This is our first year for exams. There is a need to continue to think about student supports for this setting.

4. Graduation Rates

- 6.a.vii.4.1. Our four year graduation rate has exceeded the state sector for all student groups.
- 6.a.vii.4.2. Graduation rates also improved notably from the Class of 2020 to 2021.

viii. Key takeaways from the data: Glows and Grows

1. Glows

- 6.a.viii.1.1. We are proud that DCI has scaled to be representative of the city's population.
- 6.a.viii.1.2. Students and families want to be at DCI.
- 6.a.viii.1.3. Students are developing a sense of agency.

- 6.a.viii.1.4. DCI is performing above national norms.
- 6.a.viii.1.5. We have not seen school-wide learning loss.

2. Grows

- 6.a.viii.2.1. The scale of the student population has tripled in a short period of time and the composition of students has shifted. This is expected as the city gentrifies.

- 6.a.viii.2.3. We see gaps for certain student sub groups.
- 6.a.viii.2.4. Chinese mastery is more challenging.

ix. What are the implications of the data for SY22-23?

- 1. We need to ensure staffing, facilities, extracurriculars, and alumni support reflect the size of the school now that DCI is at scale.
- 2. We need to ensure we provide the resources needed for addressing key learning gaps.
- 3. We need to consider more support for students with disabilities and English learners, especially in language classes and IB.
- 4. We need to conduct additional analysis to understand trends for the program over time.

x. Questions/Comments:

- 1. Is this comparative IB data also inclusive of private schools? IB and AP data shown here as a comparison to DC is from public schools.
- 2. Does DCI have in school suspension? And how is the school using ISS as a preventative intervention to reduce out of school suspension? Yes, we have multiple iterations of ISS that we use before we move to OSS. We try to keep students in the building as much as possible.
- 3. It is a testament to the type of learning happening here and the teachers and staff to be having these types of results during such a hard time. Other schools are talking about learning loss and accelerated learning so that they stay on grade level.
- 4. Thank you to the staff. We have shown we can hold true to the school's mission.
- We have such a diverse student population. This data shows that it is necessary to expand access to the IB across the city and country for all groups.
- 6. From the RSVP form: Question about staffing for 9th grade English. Answer: We have been working with our staff to see who is able to take on more classes. We now have coverage for all of our English classes. We have been having challenges with hiring mid-year; everyone is looking for the next school year not this year. We have made some pivots - all English classes are covered

- with permanent teachers. Mr. Nace is happy to talk about any specific 9th grade questions/concerns.
- 7. From the RSVP form: Request for your comments overall about the number of staff who have left this year. Answer: It has been a hard year. "The Great Resignation" is happening around the country. Education and healthcare have been the most hard hit. All of the staff teach classes or sub. It has been a hard year to get people back in person and to hire for new positions. We're working really hard to be fully hired for next year and get through this year. We want to give staff time and energy back so that they can be productive and here for the kids. DCPS has 5600 vacancies. We have a new Spanish teacher coming and are getting people in the door for now.
