- 1. Craig Barrett called the meeting to order at 4:38pm ET
- 2. The agenda was adopted as presented.

- 3. Members of the public had the opportunity to submit comments in advance of the meeting and there was a call to the public during the meeting. No public comment was received.

The BASIS.ed team presented the quarterly Management Report that included the following: Academic performance related to recent assessments and supports being provided to set students up for success; current status of enrollment applications through My School DC and enrollment projections; proposal for additional marketing including metro and bus ads; open positions in and recruiting efforts for the upcoming school year; contributions to the ATF and upcoming events; and the status of previous and ongoing compliance matters.
