



Notice of Petition to Amend Charter:  
Additional Facility – **The Children's Guild DC PCS**

ACTION: Open for Public Comment

PUBLIC COMMENT ACCEPTED UNTIL: **November 18, 2019**

**SUMMARY:** The District of Columbia Public Charter School Board (DC PCSB) announces an opportunity for the public to submit comment on a request submitted by The Children's Guild DC Public Charter School (Children's Guild PCS) on September 24, 2019 to operate at a second facility.

Children's Guild PCS is currently in its fifth year of operation serving students in grades K-8 at a single campus in Ward 5. The school's existing facility is located at 2146 24<sup>th</sup> Place, NE. Effective for school year 2020-21, Children's Guild PCS requests to operate at a second facility in Ward 5 located at 2130 24<sup>th</sup> Place NE. The proposed new location is directly adjacent to the school's primary facility, located just a few feet away from the main campus. If approved, Children's Guild PCS plans to use the proposed facility part-time to conduct its physical education and recreational programming.

Pursuant to the School Reform Act, D.C. Code 38-1802 et seq., a charter school must submit a petition to revise its charter, which includes its campus locations.
